

RESOLUTION OF THE BOARD OF EDUCATION
SHERRARD COMMUNITY UNIT SCHOOL DISTRICT #200
ROCK ISLAND AND MERCER COUNTIES, STATE OF ILLINOIS

WHEREAS, the State of Illinois has enacted the Prevailing Wage Act and

WHEREAS, the aforesaid Act requires that the Sherrard Community Unit School District #200, Rock Island and Mercer Counties, Illinois, investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Sherrard Community Unit School District #200 employed in performing construction of public works, for said Sherrard Community Unit School District #200.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF SHERRARD COMMUNITY UNIT SCHOOL DISTRICT #200:

SECTION 1: To the extent and as required by the Prevailing Wage Act, the general prevailing rate of wages in this locality of laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Sherrard Community Unit School District #200 is hereby ascertained to be the same as the prevailing rates of wages for construction work in the Rock Island/Mercer Counties area as determined by the Department of Labor of the State of Illinois as of June of the current year, a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department of Labor of the State of Illinois shall supercede the Department's June determination and apply to any and all public works construction undertaken by Sherrard Community Unit School District #200. The definition of any terms appearing in this Resolution which are also used in aforesaid Act shall be the same as in said Act.

SECTION 2: Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Sherrard Community Unit School District #200 to the extent required by the aforesaid Act.


SECTION 3: The Sherrard Community Unit School District #200 Clerk or Secretary shall publicly post or keep available for inspection by any interested party in the main office of Sherrard Community Unit School District #200 located in Sherrard, Illinois, this determination of such prevailing rate of wage. A copy of the determination or of the current revised determination of the prevailing rates of wages then in effect shall be attached to all contract specifications.

SECTION 4: The Sherrard Community Unit School District #200 Clerk or Secretary shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses and have requested copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5: The Sherrard Community Unit School District #200 Clerk or Secretary shall promptly file a certified copy of this Resolution with the Secretary of State of the State of Illinois.

SECTION 6: The Sherrard Community Unit School District #200 Clerk or Secretary shall cause to be published in a newspaper of general circulation within the area a copy of this Resolution, and such publication shall constitute notice that the determination is effective and that this is the determination of this public body.
